After careful consideration of the evidence provided, the committee ruled as follows:

The committee found T&J Electrical Associates, LLC violated Article II of the Small Works Addendum to the Inside Agreement multiple times by using CWs and CEs for work that should have been rightfully performed by Journeymen Wiremen under the terms of the Inside Agreement.

As a result of the violations T&J Electrical Associates, LLC is ordered to pay a total of \$4,632.14 as set forth in Attachment 1.

Future repeated violations of Article II of the Small Works Addendum may result in additional penalties including but not limited to the suspension of the Employer's ability to perform work under the addendum.

Please be advised that notice of a Petition for Grievance is being filed by IBEW Local 236 against T&J Electrical Associates, LLC. with a request that this matter be heard before the Labor Management Committee (LMC) on **Wednesday December 2**, at 11:00 A.M. at the Albany NECA Chapter Office, 16 Wade Road, Latham, NY.

The grievance scheduled to be heard stems from a charge filed by the Local against Contractor as follows:

### Charge:

**a.** IBEW Local 236 alleges T&J Electrical Associates violated the Small Works Addendum to the Inside Agreement.

### **Background:**

Grievant alleges that T&J Electrical Associates used Construction Wiremen and Construction Electricians on work outside of the scope of the Small Works Addendum by using four (4) Construction Wiremen and six (6) Construction Electricians on various projects at Hudson Valley Community College, and three (3) Construction Wiremen and one (1) Construction Electrician at Samaritan Hospital in Troy, NY.

### **Remedy Sought By Grievant:**

T&J Electrical Associates to pay the difference between the Construction Wireman and Construction Electrician pay rate and benefits and the Journeyman Wireman pay rate and benefits which totals \$35,637.20 plus assessments due Local 236.
